
**PROMOTION & INSTALLATION OF HIGH EFFICIENCY IRRIGATION
SYSTEM (HEIS)**

REQUEST FOR EXPRESSION OF INTEREST

1. The Government of Islamic Republic of Pakistan has received a credit from the International Development Association (IDA) towards the cost of six (06) years Sindh Irrigated Agriculture Productivity Enhancement Project (SIAPEP) being implemented since 2015 in the entire Sindh province and intends to apply part of its proceeds for installation of High Efficiency Irrigation System (HEIS).
2. Under the Project, the HEIS (Drip Irrigation System) will be installed on about 2,648 HEIS Farms (35,240 Acres) in cultivatable land throughout Sindh Province.
3. The HEIS (Drip System) will be installed on subsidy basis (The project will contribute a share of 60% and the farmer /beneficiary will contribute a share of 40%) for row and orchard crops under certain criteria set out by the Project. The farmers will be free to choose the reputable Companies/ Supply & Service Company (SSC) and negotiate the rates for HEIS installation on his / her Agriculture Farm / Land.
4. The Project Director – PIU, Sindh Irrigated Agriculture Productivity Enhancement Project intends to invite eligible Companies/ SSCs/firms / Consortiums / Joint Ventures having specific and proven competence and experience in installation of high efficiency irrigation systems on turnkey basis and provision of post-installation services under projects of similar nature to indicate their interest.
5. The Project intend to establish the list of interested Companies/SSCs/Consortiums/Joint Ventures for current ongoing year 2018-19, who meet the eligibility criteria.
6. The interested HEIS Companies/SSCs/Consortiums/Joint Ventures throughout Pakistan are advised to submit Expression of Interest in a written form (01 original, 01 copy and a soft copy in a commonly used/ legible format on CD) to the address below (in person, or by courier) with following documents and information by **November, 27, 2018 before 5,00 pm (PST)**
 - Detail of established office addresses /contacts details of company/SSC/ Consortium/Joint Venture;
 - Valid Tax Registration certificate in Pakistan and ability to undertake documented transaction;
 - Company registration certificate with valid registration authority;
 - Detail of professionals with CVs (Technical & Non-Technical) HEIS staff;
 - Experience in HEIS installation, (row & orchard) if any;

- List of HEIS equipment with detail specification, Make/Model to meet ISO standards etc.;
- Certificate of willingness to train the farmer in O & M of HEIS in growing crops under HEIS;
- Certificate of willingness to provide after sale services free of cost to farmers for one year;
- Certificate to abide the rules and regulation defined by Project;

Contact details of the eligible Companies/SSCs /Consortiums/Joint Ventures will be published on the project website and will be shared with the beneficiaries. Beneficiaries will be making the final choice and will negotiate the price with company/SSC/ Consortium/Joint Venture and sign a contract
